The Reporting Person agreed to cancellation of the stock option granted to him on August 29, 2012, in exchange for a new option issued on October 15, 2014 pursuant to the Issuer's 2013 Stock Incentive Plan, which option is exercisable for the same number of shares and subject to the same vesting schedule, but with a longer term and lower exercise price.
- (3) Of the shares issuable pursuant to this stock option, 573,391 are currently vested. The remaining 163,826 shares are scheduled to vest on August 29, 2015.
