(1) Each restricted stock unit is the economic equivalent of one share of ICF International, Inc.'s Common Stock.

(2) These acquired restricted stock units were granted pursuant to ICF International, Inc.'s 2010 Omnibus Incentive Plan, as amended. These restricted stock units vest over a period of 4 years at 25% per year beginning one year from the date of grant.

Mr. Wasson's Form 4 filed on March 22, 2016 incorrectly stated that he was awarded 4,729 restricted stock units (RSUs) on March 21, 2016. Mr. Wasson's aggregate award was 16,686 RSUs: (i) 4,729 RSUs granted as a bonus and (ii) 11,957 RSUs granted as a portion of his annual equity incentive award. This amendment accurately reflects both components of Mr. Wasson's RSU award on March 21, 2016.
