- (1) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The units are to be settled 100% in cash subject to vesting provisions.
- (2) Award of restricted stock units. Fifty percent vests on October 1, 2010 and 50% on October 1, 2012, contingent upon continued employment with the company.
- (3) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
