Roderick Wong is the Managing Partner of the Adviser. The beneficial ownership percentage reported herein is based on 138,616,170 voting Shares issued and outstanding as of November 1, 2018, as disclosed in the Company’s Quarterly Report filed with the Securities and Exchange Commission on November 7, 2018. This report shall not be deemed an admission that the Adviser, the Funds or any other person is the beneficial owner of the securities reported herein for purposes of Section 13 of the Securities Exchange Act of 1934, as amended, or for any other purpose. Each of the reporting persons herein disclaims beneficial ownership of the Shares reported herein except to the extent of the reporting person’s pecuniary interest therein.
