- In connection with our IPO, and pursuant to the terms of the Separation and Distribution Agreement, dated as of May 25, 2011, by and among the Issuer, Forest Oil Corporation ("Forest") and Canadian Forest Oil Ltd. (CFOL"), Forest contributed to the Issuer its (1) approximate 86.6% direct ownership interest in CFOL and its 100% direct and indirect ownership interest in each of Wisser Oil Delaware, LLC and Wisser Delaware LLC, which collectively own the remaining ownership interest in CFOL, in exchange for 69,999,999 shares of the Issuer's common stock.
