- The Reporting Person was awarded a grant of 24,316 restricted stock units (RSUs). The RSUs vest in full on the five year anniversary of the grant date (i.e., December 3, 2017), provided the Reporting Person is still an employee of the Issuer on that date. Each RSU represents the contingent right to receive one share of RGS common stock upon vesting.
