Item 1. Security and Issuer

This Amendment No. 3 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated June 3, 2014 and filed with the SEC on June 4, 2014 (the "Original Schedule 13D"), as amended by Amendment No. 1 dated June 8, 2015 and filed with the SEC on June 9, 2015 ("Amendment No. 1"), and as further amended by Amendment No. 2 dated July 1, 2016 and filed with the SEC on July 6, 2016 ("Amendment No. 2"), for Bank of America Corporation ("BAC") and Banc of America Preferred Funding Corporation ("BAPFC") (collectively, the "Reporting Persons") with respect to the variable rate munifund term preferred shares ("VMTP Shares") and the adjustable rate munifund term preferred shares ("AMTP Shares") of Nuveen New York Quality Municipal Income Fund (the "Issuer") formerly known as Nuveen New York Dividend Advantage Municipal Fund.

This Amendment is being filed as a result of the exchange (the "Exchange") of the Reporting Persons' (i) 1,470 VMTP Shares, Series 2019 (CUSIP No. 67066X800) for an equal number of AMTP Shares, Series 2028 (CUSIP No. 670654102) of the Issuer.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"The Reporting Persons exchanged (i) 1,470 VMTP Shares, Series 2019 (CUSIP No. 67066X800) for an equal number of AMTP Shares, Series 2028 (CUSIP No. 670654102) of the Issuer.

The Exchange was a cashless exchange and no funds were used by the Reporting Persons."

Item 4. Purpose of Transaction

Item 4 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"The Reporting Persons acquired the AMTP Shares for investment purposes. The Reporting Persons acquired the AMTP Shares directly from the Issuer pursuant to the Exchange Agreement, dated December 13, 2018, between the Issuer and BAPFC (the "Exchange Agreement"), on their initial issuance in a cashless exchange transaction.

The Reporting Persons have not acquired the subject securities with any purpose, or with the effect of, changing or influencing control of the Issuer, or in connection with or as a participant in any transaction having that purpose or effect."
