(1) The 405 variable rate demand preferred shares ("Shares") reported as acquired in Table I represent Shares of BlackRock New York Municipal Income Quality Trust (the "Issuer") beneficially owned by Banc of America Preferred Funding Corporation ("PFC"). The Shares were acquired for a purchase price of \$100,099.561654 per share (representing \$100,000 per share liquidation preference and accrued dividends of \$99.561654 per share). PFC is a wholly owned subsidiary of Bank of America Corporation ("Bank of America").

(2) This statement is jointly filed by Bank of America and PFC. Bank of America holds an indirect interest in the securities listed in Table I (the "Securities") by virtue of its indirect ownership of its subsidiary PFC.
