- (1) At the stockholders meeting in 2015, the stockholders approved an amendment to the Company's Amended and Restated Certificate of Incorporation to declassify the Company's Board of Directors and provide for the annual election of directors. As such, the director grants are being made to coincide with the one-year term of office. These grants vest on the first to occur of May 17, 2019 or the 2019 Annual Meeting of Stockholders.
  - (2) 130,969 shares are held by a limited partnership and the Reporting Person is a general partner of the limited partnership.
  - (3) 5,000 shares are held in trust for the benefit of the reporting person's children. The reporting person's spouse is trustee of the trust. The reporting person disclaims beneficial ownership of such securities.
