- 2,162 shares were withheld by the issuer to satisfy income tax withholding requirements related to the lapsing of restrictions on (a) 942 shares of restricted stock awarded to the reporting person on May 17, 2018 (Form 4 filed 5/21/18) (b) 2,137 shares of restricted stock awarded to the reporting person on May 18, 2017 (Form 4s filed 5/22/17 and 5/9/18); (c) 684 shares of restricted stock awarded to the reporting person on May 20, 2016 (Form 4 filed 5/12/17); (d) 871 shares of restricted stock awarded to the reporting person on June 10, 2015 (Form 4 filed 5/10/16); and (e) 858 shares of restricted stock awarded to the reporting person on June 3, 2014 (Form 4 filed 5/7/15).
