On March 7, 2013, Amtech Systems, Inc. (the "Company") held its Annual Meeting of Shareholders. The total number of shares represented in person or by proxy was 7,236,597 or 75.9 percent of the 9,539,234 shares eligible to vote. The results of the votes are as follows:
