Goldman Sachs and GS Group may be deemed to beneficially own indirectly, in the aggregate, 14,057,137 common shares of the Company, par value \$ 0.175 per share (the "Common Shares") and 1,604,410.1 warrants to purchase Common Shares by reason of the beneficial ownership of such shares by certain investment partnerships of which affiliates of Goldman Sachs and GS Group are the general partner, managing general partner or managing limited partner.
