- (1) This amended Form 4 is being filed to correct information in a Form 4 filed by the reporting person on May 31, 2011. The original Form 4 erroneously indicated that the reporting person acquired 1,666 shares of common stock of the Issuer on May 29, 2011. No such acquisition occurred. Rather, restrictions lapsed on May 29, 2011 on 1,666 shares of common stock of the Issuer that had been previously awarded to the reporting person. Consequently, Table 1 of the original Form 4 overstated the amount of securities beneficially owned by the reporting person by 1,666. This amended Form 4 corrects the number of shares beneficially owned by the reporting person as of May 29, 2011.
