Marcus and Marcus Family Holdings LLC that this Schedule 13G is filed on behalf of each of them.

- (v) 19,436 shares of Class B Common Stock held individually by Mr. Marcus;
- (vi) 2,689,812 shares of Class B Common Stock held by the Marcus Family Holdings LLC;
- (vii) 77,560 shares of Class B Common Stock held individually by Mr. Marcus wife;
- (viii) 652,179 shares of Class B Common Stock held by trusts whereby Mr. Marcus wife serves as Trustee;
- (ix) 210,078 shares of Class B Common Stock held by trusts whereby Mr. Marcus serves as Trustee;
- (x) 107,621 shares of Class B Common Stock held by trusts whereby Mr. Marcus and his wife serve as Co-Trustees; and
- (xi) 2,701,056 shares of Class B Common Stock held by trusts whereby Mr. Marcus and his sister, Diane Marcus Gershowitz, serve as Co-Trustees.

The trusts, Mr. Marcus and Ms. Marcus, for shares held individually, each have the right to receive dividends and proceeds from the sale of securities held thereby.
