- (1) Merger Sub Inc., which became effective on October 1, 2015, in exchange for 7,250 Wright Medical Group N.V. ("Wright N.V.") ordinary shares having a market value of \$20.39 per share at the effective time of the merger.
  - (2) The employee stock option vests in equal annual installments over a period of four years after the grant date
  - (3) This option was assumed by Wright N.V. in the merger and replaced with an option to purchase 54,122 Wright N.V. at a price of \$20.21 per share.
  - (4) This option was assumed by Wright N.V. in the merger and replaced with an option to purchase 18,709 Wright N.V. at a price of \$29.06 per share.
