("TP"), a Delaware limited partnership. The Reporting Person is also the managing member of Tontine Capital Management, L.L.C. ("TCM"), a Delaware limited liability company, the general partner of Tontine Capital Partners, L.P. ("TCP"), a Delaware limited partnership. The Reporting Person is also the managing member of Tontine Overseas Associates, L.L.C., a Delaware limited liability company ("TOA"), the investment adviser to Tontine Capital Overseas Master Fund, L.P., a Cayman Islands partnership ("TCO") and Tontine Overseas Fund, Ltd., a Cayman Islands corporation ("TOF").

(2) The Reporting Person directly owns 0 shares of the Common Stock. TP directly owns 757,398 shares of Common Stock. TCP directly owns 3,726,000 shares of Common Stock.
