Reporting Person was then sole stockholder of EQK and thus held beneficial interest in the 922,737 shares of TCI stock sold. On 1/21/2011, Reporting Person disposed of all ownership of EQK and thereby ceased to have any beneficial ownership in any shares of TCI common stock.
