This statement constitutes Amendment No. 1 to the statement on Schedule 13D

(the "Schedule 13D") filed with the Securities and Exchange Commission by Bear, Stearns & Co. Inc. ("Bear Stearns") with respect to its ownership of the Common Stock of Active Voice Corp. (the "Issuer").

Item 3: Source and Amount of Funds or Other Consideration

Working capital of Bear Stearns & Co. The aggregate purchase price of the 157,267 shares of Common Stock was approximately \$2,476,955.

Item 5: Interest in Securities of the Issuer (as of 02/12/01)

- (a) The responses of Bear Stearns to Rows (11) through (13) of the cover page of this Amendment No. 1 to Schedule 13D are incorporated herein by reference. To the best of Bear Stearns' knowledge, none of its executive officers or directors beneficially own any Common Stock of the Issuer.
- (b) The responses of Bear Stearns to Rows (7) through (10) of the cover page of this Amendment No. 1 to Schedule 13D are incorporated herein by reference.
- (c) Since the date of its initial filing on Schedule 13D, Bear Stearns has effected transactions in the Common Stock of the Issuer. Information concerning transactions in the Common Stock effected by Bear Stearns is set forth on Appendix I.
- (d) Not Applicable.
- (e) Through February 12, 2001, Bear Stearns purchased an additional 157,267 shares of Active Voice Corp. Accordingly, Bear Stearns increased its beneficial ownership by more than one full percentage points of the Common Stock of the Issuer since the date of its initial filing.
