The following constitutes Amendment No. 2 to the Schedule 13D filed by the undersigned (“Amendment No. 2”). This Amendment No. 2 amends the Schedule 13D as specifically set forth herein.

Item 4. Purpose of Transaction.

Item 4 is hereby amended to add the following:

On September 3, 2013, Starboard issued an open letter to the shareholders of the Issuer. In the letter, Starboard provided an update on its efforts to secure a superior proposal to the proposed merger between the Issuer and Shuanghui International Holdings Limited (the “Proposed Merger”), and stated its intentions to vote against the Proposed Merger at the special meeting of shareholders, currently scheduled to be held on September 24, 2013 (the “Special Meeting”), to allow Starboard time to facilitate a potential superior proposal. The letter explained that, in Starboard’s view, the Issuer has the ability to unilaterally postpone or adjourn the Special Meeting “to allow reasonable additional time to solicit additional proxies” if Smithfield has not received sufficient votes to approve the Proposed Merger.

The full text of the September 3, 2013 letter is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
