Item 5.07. Submission of Matters to a Vote of Security Holders

On May 11, 2011, Great Southern Bancorp, Inc. ("Bancorp") held its Annual Meeting of Stockholders. Of the 13,452,498 shares entitled to vote at the meeting (without reduction for 10% voting limitation in Bancorp's charter), 10,185,562 were present at the meeting in person or by proxy. The results of the meeting, which exclude 780,346 shares beneficially owned in excess of the 10% voting limitation by the persons believed by Bancorp to be subject to that limitation, are as follows:

1) Election of two directors, each for a term of three years:

3) Ratification of the appointment of BKD, LLP as Bancorp's independent registered public accounting firm for the fiscal year ending December 31, 2011:
