Within the scope of our Board of Directors' share buy-back decision on July 27, 2016, our company purchased a total of 104,000 shares at a price range of TRY 9.58 – 9.60 totaling TRY 997,120 on November 9, 2016. With this transaction, our ratio of shares in company capital have reached 0.129%.
