TELECOM ITALIA SUCCESSFULLY PRICES 400 MILLION EURO 9-YEAR BOND ISSUE

The issue will take place via private placement

Milan, 31 May 2007 - Telecom Italia today successfully priced a floating-rate bond issue for a total value of 400 million Euro and with maturity in June 2016.

With this operation, Telecom Italia has taken advantage of favourable market conditions to re-finance maturing debt and reduce its average overall cost.

The terms set for the issue are as follows:

- issuer: Telecom Italia S.p.A.

- amount: 400 million euro

- issue date: 7 June 2007

- maturity: 7 June 2016

duration: 9 years

coupon: Euribor + 0.79% payable quarterly

•

issue price: 100.00%

•

effective yield at maturity: Euribor 3 month +0.79%

The operation which took the form of a *private placement* is part of Telecom Italia's 15 billion euro Euro Medium Term Note (EMTN) programme.

The issue will be quoted on the Luxembourg stock exchange.
