Capital Group International, Inc. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 30,938,750 shares or 2.9% of the 1,072,342,272 Ordinary shares, including American Depositary Shares, believed to be outstanding.
