histadrut to be a representing labor union in the company  
and netvision

Netanya, Israel – July 2, 2013 – Cellcom Israel Ltd. (NYSE: CEL) (TASE: CEL) (hereinafter: the "Company") announced today that following the previously reported primary organization of Cellcom Israel and 013 Netvision Ltd.'s employees under a labor union, the Company received a notice from the Histadrut, an Israeli labor union, claiming the required minimum number of employees for the organization to be recognized as a representing labor union joined the Histadrut. The Company intends to request details from the Histadrut and will examine the notice.
