Venezuela owns 100% of the equity of Verizon Europe Holdings. VIHL owns 100% of the equity of Venezuela. BANHI owns 95.6% of the equity of VIHL. BALAH owns 100% of the equity of BANHI. GTE Venezuela owns 100% of the equity of BALAH. GTE International owns 100% of the equity of GTE Venezuela. GTE owns 68.6% of the equity of GTE International. Verizon owns 100% of the equity of GTE. By virtue of the relationships among such companies, each of them may be deemed to have had shared power to vote and dispose of, or to direct the vote and disposition of, the Ordinary Shares of STET Hellas previously owned by Verizon Europe Holdings. As of the date of this report, none of the reporting persons has any power to vote and dispose of, or to direct the vote and disposition of, any Ordinary Shares of STET Hellas.
