Progress on share repurchase programme ING

ING announced today that, in line with the launch of its EUR 5.0 billion share buy back programme on 4 June 2007, the company has repurchased 8,645,000 (depository receipts for) shares during the week of 5 November until 12 November.

The (depository receipts for) shares were repurchased at an average price of EUR 28.32 for a total amount of EUR 245,689,925.00. For detailed information on the daily repurchased shares, see the ING website at www.ing.com/investorrelations.

The total number of (depository receipts for) shares repurchased under this programme to date is 77,635,474 ordinary shares for a total consideration of EUR 2,418,396,582.50. To date approximately 48.4% of the repurchase programme has been completed.

The repurchase programme is expected to run until June 2008.
