SIGNIFICANT EVENT

Today, TELEFÓNICA, S.A., through its wholly- owned subsidiary TELEFÓNICA EMISIONES, S.A.U., under its Guaranteed Euro Medium Term Note Programme (EMTN Programme) filed with the Financial Services Authority (FSA) in London on July 3rd, 2009, has launched an issue of Notes guaranteed by TELEFÓNICA, S.A. in the Euro market amounting 650 million sterling pounds.

These thirteen (13) year Notes pay an annual coupon of 5.289% and have a reoffer price of 100%. Settlement and closing date is scheduled for execution on December 10th, 2009.
