As reported in a press release dated March 14, 2006, First Bancorp (the "Company") did not file its annual report on Form 10-K for the fiscal year ended December 31, 2005 and is still in the process of preparing restated financial statements to correct the accounting for certain mortgage-related transactions that the subsidiary Bank entered into with other financial institutions and for the interest rate swaps that it uses to hedge interest rate risk. In addition, the restatement may also address other accounting matters identified as part of the on-going restatement process. First BanCorp intends to complete the restatement process and file restated financial statements with the Securities and Exchange Commission in the summer of 2006. The Company expects to file the 2005 annual report on Form 10-K, restate the Quarterly Report on Form 10-Q for the period ended March 31, 2005 and file the remaining two Quarterly Reports of 2005 and the Quarterly Report for the periods ended March 31, 2006 and June 30, 2006 on Form 10-Q thereafter.
