**SECTION 1 REGISTRANT'S BUSINESS AND OPERATIONS**

**Item 1.01 Entry Into a Material Definitive Agreement**

Nord Resources Corporation (the Corporation) has entered into an extension agreement with respect to its replacement cathode sales agreement with Red Kite Master Fund Limited (Red Kite) that covered the period from January 1, 2013 through September 30, 2013, for 100% of the copper cathode production from the Johnson Camp Mine. The replacement cathode sales agreement was executed by the parties upon the expiry of the long term copper cathode sales agreement that was in place from February 1, 2008 through December 31, 2012. The extension runs through December 31, 2013 with renewable extensions by mutual agreement of both parties. Pursuant to the agreement, Red Kite will accept delivery of the cathodes at the Johnson Camp Mine, and pricing will be based on the COMEX price for high-grade copper on the date of sale. Red Kite is a large metals hedge fund and physical trader.

The Corporation is planning to file the extension agreement as an exhibit to its quarterly report on Form 10-Q for the three-month period ending September 30, 2013
