- On October 6, 2008, TRT Holdings, Inc. ("TRT") purchased 49,700 shares of the common stock of Gaylord Entertainment Company ("GEC") in 305 open market purchases, at prices ranging from \$21.72 to \$22.00 per share, and with a weighted-average per-share price of \$21.9424.
- (1) On October 7, 2008, TRT purchased 8,600 shares of the common stock of GEC in 52 open market purchases, at prices ranging from \$21.84 to \$21.99 per share, and with a weighted-average per-share price of \$21.9557.
 - (2) TRT agrees to provide, upon request by the Securities Exchange Commission, GEC, or a holder of the common stock of GEC, full information regarding the number of shares purchased at each separate price.
 - (3) The reported securities are owned directly by TRT. Robert B. Rowling indirectly beneficially owns the reported securities due to his ownership of all of the Class B shares of Common Stock of TRT.
