Item 8.01 Other Events

On May 20, 2014, Aon plc (the **Company**) and Aon Corporation (the **Guarantor**) entered into an Underwriting Agreement (the **Underwriting Agreement**) with Citigroup Global Markets Inc., J.P. Morgan Securities LLC, Merrill Lynch, Pierce, Fenner & Smith Incorporated and Morgan Stanley & Co. LLC, as Representatives of the several Underwriters named therein, with respect to the offering and sale by the Company of \$250,000,000 aggregate principal amount of its 3.500% Senior Notes due 2024 and \$550,000,000 aggregate principal amount of its 4.600% Senior Notes due 2044 (collectively, the **Notes**), under the Registration Statement on Form S-3 (Registration No. 333-183686). The Guarantor will provide a full and unconditional guarantee of the Notes pursuant to the Indenture (as defined below) (the **Guarantee**, and together with the Notes, the **Securities**). The Securities will be issued pursuant to an Indenture, dated as of May 24, 2013, among the Company, the Guarantor and The Bank of New York Mellon Trust Company, N.A., as trustee (the **Indenture**).

The net proceeds from the sale of the Securities after deducting the underwriting discounts and estimated offering expenses payable by us, are expected to be approximately \$790.3 million. We intend to use the net proceeds from this offering for general corporate purposes.

The Underwriting Agreement is filed as Exhibit 1.1 to this Current Report on Form 8-K and is incorporated herein by reference. The Indenture (including the Guarantee) was filed as Exhibit 4.1 to a Current Report on Form 8-K on May 24, 2013 and is incorporated herein by reference. The form of notes for the Notes is filed as Exhibit 4.2 and 4.3 to this Current Report filed by Aon plc on Form 8-K and is incorporated herein by reference.

In connection with the issuance of the Securities, Latham & Watkins LLP is filing the legal opinions attached to this Current Report on Form 8-K as Exhibits 5.1 and 5.2, respectively.
