**Item 2.02 Results of Operation and Financial Condition.**

On April 28, 2016, Helen of Troy Limited (the Company) issued a press release announcing the results for the fiscal quarter and year ended February 29, 2016. Additionally, on April, 28, 2016, the Company held a conference call discussing its results for the same period mentioned above. With this Form 8-K, we are furnishing copies of the press release (attached hereto as Exhibit 99.1) and the text of the conference call (attached hereto as Exhibit 99.2).
