- (1) On February 17, 2010 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 8,354 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 17, 2013, the remaining 4,177 shares of the originally granted RSAs vested, of which 1,573 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
- (2) Between May 23, 2012 and February 19, 2013 the Reporting Person acquired 68 shares of First Midwest Bancorp, Inc. Common Stock pursuant to the Dividend Reinvestment feature under the First Midwest Bancorp, Inc. Non-Qualified Gain Deferral Plan. The information

Savings and Profit Sharing Plan pursuant to the Dividend Reinvestment feature of the Plan and 6 shares were sold from the Reporting Person's Plan account in satisfaction of quarterly Plan administration fees.
