Following the closing of the acquisition of TravelCenters of America, Inc. by HPT, HPT TA Properties plans to distribute all of its equity interest in TA to HPT, which has announced that it intends to spin off all of its shares of TA. If the distribution occurs, HPT TA Properties intends to file a Form 4 reflecting its distribution of all of its equity interests in TA to HPT.
