This statement, with respect to the shares of Common Stock, .001 par value per share of Viewpoint Corporation (hereinafter referred to as "Common Shares") is filed by:

4. AFL, a company incorporated under the laws of the Cayman Islands, British West Indies and the beneficial owner of 945,061 Common Shares which it has sole voting power and shared dispositive power with Offman, who has been granted limited trading authorization over AFL's account in which AFL's Common Shares are held; and

5. SA, a Delaware limited liability company and the beneficial owner of 34,654 Common Shares which it has sole voting power and shared dispositive power with Offman, who has been granted limited trading authorization over SA's account in which SA's Common Shares are held.
