- (1) The shares were acquired under the Molina Healthcare, Inc. 2002 Employee Stock Purchase Plan ("ESPP").

Represents the closing price of issuer's common stock on December 31, 2010. The purchase price is based on the stock's lower market price as of the two following dates: (1) July 1, 2010, the first day of the ESPP offering period, and (2) December 31, 2010, the last day of the ESPP offering period.

- (2) Increments of 2,750 shares vest on each of 3/1/2011, 3/1/2012, 3/1/2013, and 3/1/2014; increments of 2,500 shares vest on each of 3/1/2011, 3/1/2012, and 3/1/2013; 875 shares vest on 3/1/2011; and increments of 1,400 shares vest on each of 3/1/2011 and 3/1/2012. The remainder of the shares are vested.
- (3) The options are fully vested.
- (4) 2,250 options are vested; 750 options vest on 3/1/2011.
