On February 12, 2014, PG&E Corporation entered into an Equity Distribution Agreement with BNP Paribas Securities Corp., Goldman, Sachs & Co., Merrill Lynch, Pierce, Fenner & Smith Incorporated and Mitsubishi UFJ Securities (USA), Inc. pursuant to which each will act as PG&E Corporation s sales agent with respect to the offer and sale from time to time of shares of PG&E Corporation common stock (the Shares) having an aggregate gross offering price not to exceed \$500,000,000. Sales of the Shares, if any, will be made by means of ordinary brokers transactions on the New York Stock Exchange or otherwise at market prices prevailing at the time of sale or at prices related to the prevailing market prices or at negotiated prices, in block transactions, or as otherwise agreed with the applicable sales agent pursuant to the Equity Distribution Agreement.

Any Shares sold will be offered and sold pursuant to PG&E Corporation s registration statement on Form S-3 (File No. 333-193880) filed with the Securities and Exchange Commission on February 11, 2014.
