Below is the text of a letter sent by Robert J. Dickey, President and CEO of Gannett Co., Inc. ( Gannett ), to Gannett s employees on May 2, 2016.

Dear Colleagues,

I wanted to provide you with an update regarding our proposal to acquire Tribune Publishing Company. This morning, we announced that Gannett has filed preliminary proxy materials disclosing our intention to seek withhold votes in connection with Tribune s Annual Meeting of Stockholders. A copy of the release is attached.

With our actions today, we are contesting Tribune s upcoming election of directors. Withhold votes would signal that the shareholders are dissatisfied with the director candidates and want the Board to take certain action. If a significant number of Tribune shareholders withhold votes on Tribune s directors, it will send a message to the Tribune Board to substantively engage with Gannett regarding Gannett s proposal to acquire Tribune for \$12.25 per share in cash, which represents a 63% premium to Tribune s unaffected stock price.

Let me emphasize that we have not yet reached an agreement to acquire Tribune, and it is not definite that an agreement will be achieved.
