On October 27, 2016, Aerie Pharmaceuticals, Inc. (the Company) issued a press release announcing the topline results from the Company's 6-month Phase 3 Rocket 4 clinical trial for its product candidate, Rhopressa<sup>TM</sup> (netarsudil ophthalmic solution) 0.02% and separately announcing the withdrawal of the Rhopressa<sup>TM</sup> NDA, with the expectation of refiling in January 2017.
