On June 19, 2018, MetLife, Inc. (MetLife) completed an exchange of its remaining 23,155,177 shares of Brighthouse Financial, Inc. common stock for \$943,638,000 in aggregate principal amount of MetLife indebtedness held by Goldman Sachs & Co. LLC, J.P. Morgan Securities LLC, Morgan Stanley & Co. LLC, and Wells Fargo Securities, LLC. and \$86,764,707 in premium, expenses, and other related items. MetLife received and cancelled \$342,503,000 in aggregate principal amount of its 6.817% Senior Notes due 2018, \$468,963,000 in aggregate principal amount of its 7.717% Senior Notes due 2019, and \$132,172,000 in aggregate principal amount of its 4.75% Senior Notes due 2021.
