- (1) One phantom stock unit was the economic equivalent of one share of The PNC Financial Services Group, Inc. ("PNC") Common Stock. The units were settled in cash and distributed to the reporting person on the transaction date.
- (2) Pursuant to elections made by the reporting person in a prior year with respect to compensation earned as an executive officer of PNC, 3204 phantom stock units became payable in cash on January 4, 2016.

("PNC") Supplemental Incentive Savings Plan (the "SISP"). Shares of PNC common stock are not directly allocated to SISP participants, but instead are held in a unitized fund, approximately 98% of which consists of PNC common stock, and the remainder of which is invested in a money market fund. The amount of securities beneficially owned reflects 61 shares indirectly acquired for the account of the reporting person under the SISP in transactions exempt from reporting
