- (1) On February 6, 2013, the Reporting person received a grant of restricted stock units ("RSUs") covering 25,000 shares of KLA-Tencor common stock. On February 5, 2016, the Reporting Person vested twenty-five percent (25%) of such RSUs.
- (2) Includes 82 shares acquired by the Reporting Person under the KLA-Tencor Employee Stock Purchase Plan on December 31, 2015. Pursuant to such terms of the February 6, 2013 RSU grant, 2,406 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such determination date (February 5, 2016).
- (4) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
