(1) On February 24, 2016, the Compensation Committee of the Company's Board of Directors awarded the reporting person performance stock units under the Danaher Corporation 2007 Omnibus Incentive Plan. This Form 4 is being filed in connection with the determination by the Compensation Committee that the performance criteria of the award have been achieved. The award remains subject to a holding period that continues through December 31, 2020.

(2) Upon distribution, the performance stock units convert into shares of Danaher common stock on a one-for-one basis.
