Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 3,664,096 shares or 6.941% of the Common Stock outstanding of General Cable Corporation ("the Company") as a result of acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of General Cable Corporation owned by the investment companies at December 31, 2011 included 76,247 shares of Common Stock resulting from the assumed conversion of \$3,840,000 principal amount of GENERAL CABLE CV .875 11/15/13 (19.856 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of General Cable Corporation owned by the investment companies at December 31, 2011 included 520,490 shares of

Common Stock resulting from the assumed conversion of \$19,128,000 principal amount of GENERAL CABLE CV 4.5% 11/15/29 (27.2109 shares of Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR LLC, through its control of Fidelity, and the funds each has sole power to dispose of the 3,664,096 shares owned by the Funds.

Members of the family of Edward C. Johnson 3d, Chairman of FMR LLC, are the predominant owners, directly or through trusts, of Series B voting common shares of FMR LLC, representing 49% of the voting power of FMR LLC. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B voting common shares will be voted in accordance with the majority vote of Series B voting common shares. Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.

Neither FMR LLC nor Edward C. Johnson 3d, Chairman of FMR LLC, has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Strategic Advisers, Inc., 82 Devonshire Street, Boston, MA 02109, a wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, provides investment advisory services to individuals. As such, FMR LLC's beneficial ownership includes 150 shares, or 0.000%, of the Common Stock outstanding of General Cable Corporation, beneficially owned through Strategic Advisers, Inc.

Pyramis Global Advisors Trust Company ("PGATC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and a bank as defined in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 491,104 shares or 0.930% of the outstanding Common Stock of the General Cable Corporation as a result of its serving as investment manager of institutional accounts owning such shares. The number of shares of Common Stock of General Cable Corporation owned by the institutional account(s) at December 31, 2011 included 2,184 shares of Common Stock resulting from the assumed conversion of \$110,000 principal amount of GENERAL CABLE CV .875 11/15/13 (19.856 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of General Cable Corporation owned by the institutional account(s) at December 31, 2011 included 3,510 shares of Common Stock resulting from the assumed conversion of \$129,000 principal amount of GENERAL CABLE CV 4.5% 11/15/29 (27.2109 shares of Common Stock for each \$1,000 principal amount of debenture).
