On May 21, 2008 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 954 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest (1) in two equal annual installments on the first and second anniversary of the date of grant.
