Bar Harbor Bankshares (NYSE MKT: BHB) (the Company) issued a press release on January 21, 2015, announcing that the Company's Board of Directors declared at its meeting held on January 20, 2015, a quarterly cash dividend of 24.5 cents per share of common stock, representing an increase of 1.0 cents, or 4.26% compared with the prior quarter, and an increase of 2.83 cents or 13.1% compared with the first quarter of 2014. The dividend will be payable to all shareholders of record as of the close of business February 13, 2015 and will be paid on March 13, 2015.
