BHP Billiton Limited announces that on 29 October 2007 it purchased 750,000 ordinary shares of BHP Billiton Plc at an average price of 1,872.96 pence per ordinary share.

Following the above transaction, BHP Billiton Plc holds 24,265,516 of its ordinary shares as treasury shares and BHP Billiton Limited holds 14,167,510 of the ordinary shares in BHP Billiton Plc, for a total of 38,433,026 shares. The total number of BHP Billiton Plc ordinary shares in issue (excluding shares held as treasury shares and shares held by BHP Billiton Limited) is 2,242,726,036.
