This amount consists of (i) 5,290,023 shares of Common Stock owned directly by Mr. Silver over which he has sole voting and dispositive power; (ii) 1,258,539 shares of Common Stock owned by the Robert Philip Silver 2002 GRAT Article III Trust for Benefit of Spouse and Descendants (of which Mr. Silver's spouse is a co-trustee), over which Mr. Silver may be deemed to have shared voting and dispositive power; and (iii) 308,396 shares of Common Stock owned by the Silver Family Limited Partnership of which Mr. Silver is the sole general partner with sole voting and dispositive power. This amount excludes 1,313 restricted stock units granted to Mr. Silver under the Silgan Holdings Inc. 2004 Stock Incentive Plan, as amended, which restricted stock units become fully vested on June 7, 2007 at which time they will be settled in shares of Common Stock on a one-for-one basis.

As of December 31, 2006, Mr. Horrigan may be deemed to be the beneficial owner of 5,873,278 shares of Common Stock. This amount consists of (i) 5,564,882 shares of Common Stock owned directly by Mr. Horrigan over which he has sole voting and dispositive power; and (ii) 308,396 shares of Common Stock owned by the Horrigan Family Limited Partnership of which Mr. Horrigan is the sole general partner with sole voting and dispositive power. This amount excludes 1,313 restricted stock units granted to Mr. Horrigan under the Silgan Holdings Inc. 2004 Stock Incentive Plan, as amended, which restricted stock units become fully vested on June 7, 2007 at which time they will be settled in shares of Common Stock on a one-for-one basis.
