Amendment No. 1 to Form 8-A

Guggenheim Enhanced Equity Income Fund (the “Registrant”) hereby amends the Registrant’s Form 8-A, as filed on August 22, 2005 (the “Original Form 8-A”), by:

A description of the Shares is contained under the heading “Additional Information About the Common Shares of the Fund” and in the related exhibits in the Registrant’s registration statement on Form N-14, which was filed with the Securities and Exchange Commission (“Commission”) under the Securities Act of 1933, as amended, on September 1, 2016 (Registration No. 333-213449), as amended by Pre-Effective Amendment No. 1 thereto, as filed with the Commission on October 7, 2016, and Pre-Effective Amendment No. 2 thereto, as filed with the Commission on December 16, 2016, and Post-Effective Amendment No. 1 thereto, as filed with the Commission on March 20, 2017, and such description as included in the Joint Proxy Statement/Prospectus filed pursuant to Rule 497 on December 29, 2016 is deemed to be incorporated herein by reference.
