(a) AMOUNT BENEFICIALLY OWNED: As of December 31, 2004, Mr. McNamara holds 270,785 shares of the Issuer's common stock in a revocable trust for which he is the sole trustee and beneficiary. Mr. McNamara also holds options exercisable within 60 days of December 31, 2004 to purchase an additional 163,750 shares. Mr. McNamara is one of the trustees of the Richard McNamara Family Foundation, which holds 173,250 shares of the Issuer's common stock as

of December 31, 2004. Mr. McNamara disclaims beneficial ownership of the Issuer's common stock held by the Richard McNamara Family Foundation.

(b) PERCENT OF CLASS: 6.4% based on 9,355,645 shares of the Issuer's Common Stock outstanding as of October 18, 2004 as reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2004 and including all 607,785 shares which could be deemed to be beneficially owned by Mr. McNamara.

(c) THE REPORTING PERSON HAS THE POWER TO VOTE OR DISPOSE OF THE SHARES AS FOLLOWS:

(i) Sole power to vote or direct the vote: 434,535 (includes all shares held in revocable trust and options exercisable within 60 days of December 31, 2004 to purchase 163,750 shares).

(ii) Shared power to vote or direct the vote: 173,250

(iii) Sole power to dispose or direct the disposition: 434,535 (includes all shares held in revocable trust and includes options exercisable within 60 days of December 31, 2004 to purchase 163,750 shares).
